

# **CLASS ACTION: NATHALIE JUTRAS AND MATHIEU BOURDET VERSUS AIR CANADA**

## **TRANSFER OF FLIGHTS FROM AIR CANADA TO AIR CANADA ROUGE**

On September 28, 2020, the Superior Court of Québec authorized a class action against Air Canada who is alleged to have transferred flights to Air Canada Rouge LP allegedly without sufficient compensation for the class members. These allegations have not been proven in Court.

### **WHO IS A CLASS MEMBER?**

Briefly, the class action includes all persons who, in Canada, bought an airline ticket from Air Canada and whose flight was then, after March 13, 2019, transferred to Air Canada Rouge LP.

### **WHAT IS THE GOAL OF THE CLASS ACTION?**

The class action seeks to establish whether Air Canada has to monetarily compensate its customers without condition for the reduced service allegedly offered on Air Canada Rouge LP aircrafts.

### **WHAT CAN YOU RECEIVE?**

The Class Action seeks to obtain for class members compensatory damages.

### **HOW TO EXCLUDE YOURSELF?**

**If you wish to exclude yourself from the class you must** advise the Clerk of the Superior Court of Québec in the district of Montréal by registered mail to 1 Notre Dame Street East, Montréal, Québec, H2Y 1B6 **by no later than September 27<sup>th</sup> 2021.**

The request for exclusion must be made in writing with reference to the class action identified by the court file number 500-06-001002-191.

Among other reasons, people who wish to bring an individual action at their own expense may wish to exclude themselves from a class action.

### **WHO REPRESENTS THE MEMBERS?**

Nathalie Jutras and Mathieu Bourdet have been designated by the Court to represent the members of the class.
